- 4. John Perry made a motion that Guideline # Article 4, Section 5. Remove "with all players' name on roster". PASSED.
- 5. Roxanna Aguilo made a motion that request EAAD Secretary should write formal letters to all regional team to see if they are interesting to have Co-Ed Volleyball tournament for next year. Seconded by Mike Kreiger. PASSED.
- 6. Mike Kreiger made a motion that the invitational tournament's clock must stop the free throw. Seconded by Danny Gabel. PASSED.
- 7. James Ginis made a motion that EAAD seeding shall be based on the number of games including the number of winning to receive the better seeding for EAAD Regional Tournament. Seconded by John Perry. PASSED.
  Robert Jones amended motion that the seeding shall follow up by the tiebreaker; if the tiebreaker has the even numbers, then following the high points. Seconded by Mike Krieger. PASSED.
